I further understand that each participant is expected to conduct themselves in a Christ life manner, and in no way exhibit conduct which would reflect in a negative way on Parkway Baptist Church, its ministries, adult sponsors, etc. Parents or guardians should explain to their child that inappropriate behavior such as disrespect or disobedience for ministry leaders/sponsors, bring any form or weapon, alcohol, or drugs, engaging in any form or vandalism, or exhibiting any conduct which would impact the safety, spiritual mission, or the cooperative spirit of the group, will result in the immediate notification of the parents, If the matter cannot be resolved through a telephone conversation between the ministry leaders, child and parents, then the individual will be sent home at the expense of the parents/guardians.
